Stabling available. All horses are required to have a stall. Stabling fee is \$40.00 for barn C and \$35 for barn D. Arrivals on the day prior to the show are acceptable between 3pm and 8pm and require a stabling fee for an additional day. Shavings available: \$9.00/bag

Entry Fees:

Classes: 1-28 \$25.00/class. Office Fee: \$15.00/entry. Late Fee: \$10.00/entry if received after closing date. Refunds, less the office fee, will be given with a vet certificate only. Current negative coggins required: Health certificate required for out-of-state horses. **Vaccination records within one year must be provided with entry.**
